Programs were also held by other groups, including the American Academy of Oral Medicine, the American Academy of Implant Dentistry, and the New York area associations of dental assistants and hygienists.

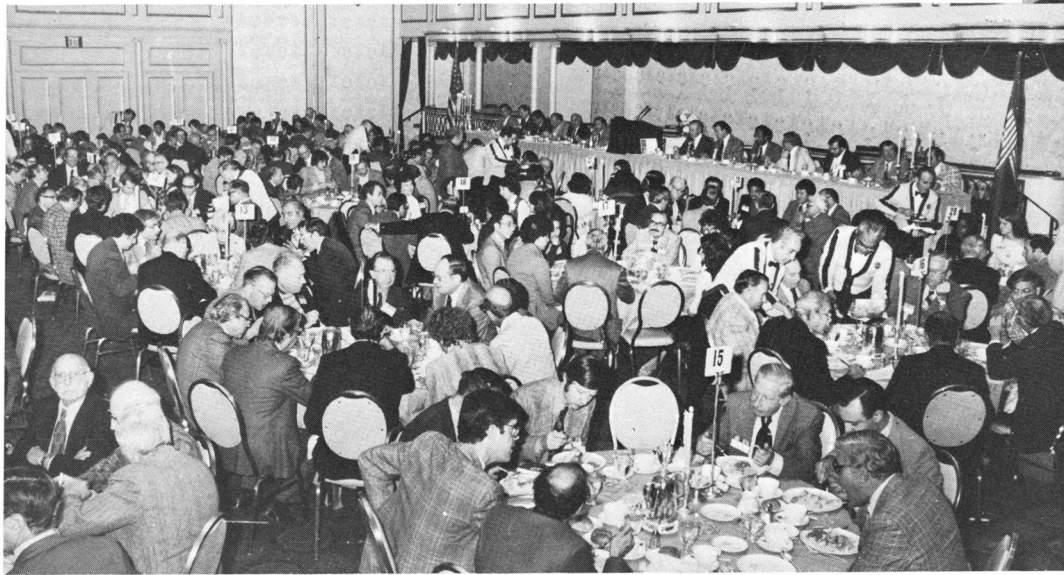

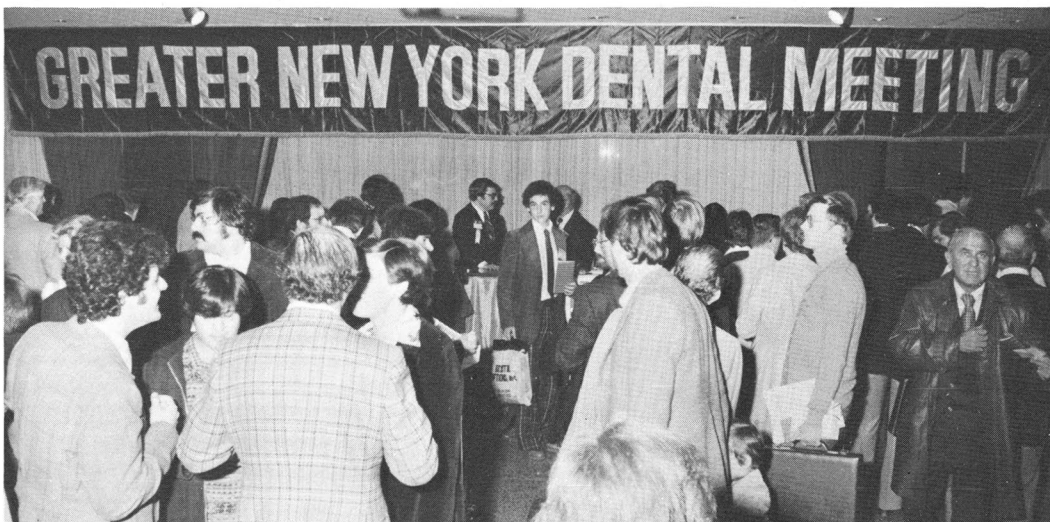
